## **ENROLLMENT AGREEMENT**

*By submitting a registration form, you are agreeing to the following.*

### **\*CAMPER**

The KNOX SCHOOL SUMMER ADVENTURES (“the Camp”) and the Parent or Guardian signing below who is financially responsible for the Camper (“the Parent”) hereby enter into this Enrollment Agreement in reference to the Camp’s offer of enrollment for the Camp season of 2019 subject to the terms and conditions listed below.

**\*TUITION/FINANCIAL OBLIGATIONS:** Rates are as listed in our 2019 Summer Day Camp Rates schedule posted on line. Add-on days are billed at the existing day rate at the time of extension, and must be paid in full at the time of addition.

**Pre-Registration Rates** must be paid in full by specified dates– **Early Bird Rates: 3/15/19. Regular Rates: 6/15/19.**

**Daily Rates** – any camp days added after the start of camp will be subject to a daily rate and must be paid in full at the time of camp attendance.

**Knox Summer Adventures reserves the right to cancel the child’s enrollment if full payment is not received prior to the start of camp.**

**\*CHANGE FEES** – A fee of \$30 will be billed for any changes to the original registration form for any reason, after 6/1/19. This fee cannot be waived under any circumstances. **\* LATE FEE** Any outstanding balances as of July 1, 2019 will be assessed a 5% late fee.

### **\* SECURITY FOR NON-PAYMENT**

Camper families with outstanding account balances from the previous summer will not be eligible for enrollment. A late fee of \$50 per month as well as an 18% finance charge will be charged to any invoice that remains unpaid as of September 1, 2019. As of October 1, 2019 all open balances will be forwarded to collections and all attorney fees, filing fees or collection fees will become the responsibility of the delinquent party.

### **\* MISCELLANEOUS PROVISIONS**

1. Knox School Summer Adventures reserves the right to remove a Camper at any time if his or her behavior is detrimental to the safety and well-being of any other individual in the Camp environment, **no refunds will be given.**

**\*\*Knox Summer Adventures has a Zero Tolerance Policy regarding drugs, alcohol. The use of tobacco and vaping is prohibited.**

**Bullying and violence of any kind is prohibited.**

2. A completed medical form must be on file in the Camp office no less than two weeks before Camp begins. If this is not received, the Camp can refuse a camper’s attendance to camp without any refunds toward lost days.

3. There will be no refunds or make-up days for non-consecutive missed days of camp due to illness, family matters, or injury. If a camper is absent consecutively for three days or more due to medical reasons only, a change fee of \$30.00 will be waived, provided a physician’s note is submitted appropriately evidencing medical reasons for the absences. All days must be used during the 2019 camp season.

4. Photography and videography taken at the Knox School may be used for promotional purposes; names of the campers will never be published.

5. If sunscreen is not applied by the family, The Knox School reserves the right to apply sunscreen to all campers.

6. In order to ensure the safety of all campers, early dismissal must take place by 2:30 PM or you must wait until regular dismissal time of 3:15 PM.

7. Your one buddy request must be reciprocated and the requested buddy must have be in the same age group.

8. Knox School Summer Adventures requires a 10 day minimum sign up, out of the 41 possible days of camp.

9. Returned checks and declined credit cards will be subject to a \$30.00 charge.

**This Enrollment Agreement may be cancelled in writing prior to May 1, 2019. All withdrawals/deletions made prior to May 1, 2019 will be subject to a \$150 per week cancellation fee. These rules shall apply regardless of the reason for cancellation.**

*Upon receipt of a complete and accurate registration, the Camper will be deemed enrolled.*

## **Waiver of Release of Liability**

***By enrolling my child and signing this document, I agree to and understand the following in its entirety:***

In consideration of my child being allowed to participate in any and all activities at Knox School Summer Adventures, the undersigned acknowledges, appreciates, and agrees that:

There is a possible risk of injury from activities involved in this program and while particular rules and personal discipline may reduce the risk, the risk of injury does exist.

I knowingly and fully assume any and all such risks which are inherent in the activities in which I or my child are engaged, both known and unknown, for myself and my child, even if arising out of negligence of the releases and am participating or allowing my child to participate in all activities

voluntarily and am willfully undertaking and assuming all such risks.

I willingly agree to have my child comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the nearest camp official immediately; and

I, for myself, and on the behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Knox School Summer Adventures, their officers, officials, agents and or employees, and other participants, (releases) with respect to any and all injury, disability, death or loss or damage to person or property whether arising from the negligence of the releases or otherwise.

For the general welfare of all campers, The Camp reserves the unrestricted right to dismiss any camper whose conduct or influence in the opinion of our directors, is contrary to the best interest of the campers and the camp.

Knox School Summer Camp is not responsible for any “lost” or “stolen” personal property that campers may take to camp.

**This contract constitutes the full understanding of the parties hereto and no change, modifications or waiver of any of the terms shall be effective unless in writing and signed by BOTH parties.**

I/we have read this release of liability and fully understand its terms. I/we further understand that there are certain risks inherent in the activities engaged in and I/we assume said risks. I/we have given up substantial rights by signing this release and sign it voluntarily and free from coercion. Should any portion of this agreement be determined unlawful, all other portions shall remain in full force and effect.
